# REPORT ON RUBBER BOARD'S PARTICIPATION IN THE 6<sup>th</sup> EDITION OF `TYREXPO AFRICA 2016'- HELD AT SANDTON CONVENTION CENTRE, JOHANNESBURG, SOUTH AFRICA FROM 8<sup>TH</sup> TO 10<sup>TH</sup> MARCH 201

## Introduction

Ministry of Commerce & Industry, Government of India, had approved the Rubber Board's participation in the trade fair 'Tyrexpo Africa 2016' held at Johannesburg, South Africa during 8 – 10 March 2016.

Johannesburg (Afrikaans: [jo'henəsbœrx]; also known as Jozi, Jo'burg, eGoli, and Joeys, and abbreviated as JHB) is the largest city in South Africa. It is the provincial capital of Gauteng, which is the wealthiest province in South Africa. The city is one of the 50 largest urban agglomerations in the world. The city was named and established in 1886 following the discovery of gold on what had been a farm. The city is commonly interpreted as the modern day El Dorado due to the extremely large gold deposit found along the <u>Witwatersrand</u>. While Johannesburg is not one of South Africa's three capital cities, it is the seat of the Constitutional Court, which has the final word on interpretation of South Africa's constitution as well as with issues in connection with constitutional matters. The city is the source of a large-scale gold and diamond trade. Johannesburg is one of the world's leading financial centers<sup>1</sup> and it is the economic and financial hub of South Africa, producing 16% of South Africa's gross domestic product. In a 2008 survey conducted by MasterCard, Johannesburg ranked 47 out of 50 top cities in the world as a worldwide center of commerce (the only city in Africa). Mining was the foundation of the City. Most mining companies still have their headquarters in Johannesburg. Johannesburg has Africa's largest stock exchange. Due to its commercial role, the city is the seat of the provincial government and the site of a number of government branch offices, as well as consular offices and other institutions.

## The fair, venue & Organisers

SingEx Exhibitions Pte Ltd, Singapore organized the fair. The "Tyrexpo Africa" is the biggest trade show in Africa for Tyre, Automotive Repair & Maintenance, and Tyre Accessories. The fair is being held in every three years and professionally organized. The venue was Sandton Convention Centre, Johannesburg. It had about 100 direct exhibitors. The fair drew about 2,000 trade visitors. These include visitors from most of the countries of Southern Africa.

The exhibition was held for 3 days from 08<sup>th</sup> to 10<sup>th</sup> March 2016. The Stall was F-01 in the Left corner of the entry gate. The timing of the exhibition was 10-00 am to 5-00 pm and for 10<sup>th</sup> March, from 10-00 am to 4-15 pm.

## **Deputation of Officers**

Department of Commerce, Ministry of Commerce & Industry, Government of India had approved Board's participation in the Equiplast 2011 *vide* communication F. No.11/17/2006-Plant – C dated 3<sup>rd</sup> March 2011. Apart from Board's officials, three exporters of Natural Rubber nominated by the Rubber Board participated in the fair. Sri Sudhanya Kumar Bhowmik & Sri Bijoy Gopal Karmakar had proceeded to Johannesburg from Kochi International Airport on 6<sup>th</sup> March, 2016 at 04.25 hrs via Abu Dhabi International Airport by Etihad Airways flights and reached there on the same day at 16-30 hrs. local time and camped at Hotel two hours later. Two Exporter's representative i.e. Mr. M. T. Thomas and Mr. Sam Thomas reached Johannesburg on 7<sup>th</sup> March, 2016 via Dubai and joined us at Sandton Convention Centre on 8<sup>th</sup> Morning.

We proceeded to Sandton Convention Centre on 7<sup>th</sup> March, 2016 and met the organizers. After completing necessary formalities of our registration, we had taken possession of the stall measuring 12 sq. Mtrs. in Size and arranged it. We displayed various vinyl posters of Rubber Board as well as Exporter's on processing / products of Natural Rubber. Also, we displayed in the stall specimens of various grades of RSS Sheets, Technically Specified Rubber (ISNR) and Centrifuged Latex. Various broachers of Rubber Board and exporter firm were also displayed in the stall.

### Summary of the Exhibition

The Exhibition commenced as scheduled on 08<sup>th</sup> March, 2016 at 10.00 hrs. The visiting hours to exhibition hall fixed from 10.00 hrs to 17.00 hrs, but for closing day, it was 10.00 hrs to 16.15 hrs.

The Exhibition had about 100 direct exhibitors all together. The fair drew about 2,000 trade visitors. These include visitors from most of the neighbouring countries including Madagaskar. All other stalls in Tyrexpo Africa - 2016 showcased exhibits from Tyre and Tyre Accessories products manufacturing industry with advanced machinery in Tube repairing etc. Board's stall drew substantial number of curious and information seeking crowd each day.

#### Feed Back

We would like to classify the visitors of the Rubber Board stall into (1) manufacturers of rubber products interested in import of rubber from India, (2) Agents and dealers in Automobile Tyres desirous to import Tyre and Tyre accessories from India and supply to industry, (3) businessmen exploring possibility of starting rubber business importing rubber from India and market in African Countries, (4) Corporate officials and (5) curios visitors to get first hand information about natural rubber. It is worthwhile to note here that the visitors consist of nationals not only from South Africa but also from other neighbouring countries.

The idea of branding of natural rubber by the Rubber Board encouraged many industrialists and businessmen to focus to India for sourcing rubber. Traditional importers of rubber from other rubber growing regions had reservations on quality aspects, but we could ally their fears citing stringent measures formulated to ensure the quality of the products marketed under the brand. We stressed further that brand certification procedure is meticulously framed to conform the quality of each and every bale/bundle inspected. We have supplied samples of RSS sheets and INSR blocks packed in cover with Rubber Board logo to those who had shown keen interests in importing rubber from India. Some business deals were struck at the venue itself. Many prospective importers initiated their process for import of rubber from India. The Board's participation in the exhibition was a success, as it helped us to popularise the natural rubber from India among the industrialist / entrepreneurs of many African countries.

A selected list of business cards, photographs are attached along with this report including the detail entries in Visitors Book kept in the stall.

The enquiry from visitors extended to other aspects as well. Some visitors showed their interest in setting up Tyre re-treading units / latex based rubber products with Indian technical expertise. Other enquiries included import of machinery for rubber product manufacturing, import of rubber products and to explore possibility of setting up manufacturing facility in India. These enquiries are being taken up with he respective departments of the Rubber Board and to other associations operating in Rubber Products Manufacturing sector.
